

Membership Resignation Form

A member may apply to the Registration Committee for permission to resign from registration by submitting this application. Registered Firms should refer to the resignation procedures under CPA Nova Scotia By-laws 234-238.

You may not apply for resignation if:

- (a) There are complaints pending and the request is not supported in writing by the Investigation Panel; or
- (b) There are outstanding fees or other amounts owing to CPA Nova Scotia

Instructions

1. Complete the attached application.
2. Include your original CPA Nova Scotia membership certificate, if it has been issued, with the application.
3. If the applicant is an owner or partner in a registered firm, a written request must be made to the Registration Committee to revoke the registered firm as a professional corporation, limited liability partnership, partnership, or sole proprietor.
4. You are only entitled to a refund of annual dues paid to CPA Nova Scotia if the resignation is requested and approved within 3 months of your more recent registration, registration renewal, or reinstatement of registration.

Important Information

Once resignation is completed, a former member can no longer refer to themselves as a Chartered Professional Accountant, CPA or any legacy designation (CA, CMA, or CGA) including any deviation or combination of those initials, words, or expressions where it is used to imply registration with CPA Nova Scotia in Nova Scotia.

A reinstatement fee and further requirements under the Continued Professional Development Policy will apply should a former member seek reinstatement of membership.

Any reinstatement application will be subject to re-entry requirements and the review and approval of the Registration Committee.

1. INTENT TO RESIGN

3. DECLARATION

In the Matter of my request to the Chartered Professional Accountants of Nova Scotia to resign from membership:

I Acknowledge that, pursuant to the Chartered Professional Accountants Act, Section 38, I shall not use Chartered Professional Accountant or a legacy designation or any derivation or combination of those initials, words, or expressions whether alone or in combination with other initials, words or expression where it is used to imply that I am entitled to practice as a chartered professional accountant or imply that I am registered by CPA Nova Scotia.

I Acknowledge that, pursuant to the Chartered Professional Accountants Act, Section 125, the registration committee shall review applications for reinstatement.

I Acknowledge there are re-entry requirements including the Continued Professional Development Policy and reinstatement fees as prescribed by the Board and the Registration Committee.

I Declare in accordance with By-law 235(c), which includes members who also maintained a registered firm, the following:

- (i) All client matters have been completed;
(ii) Satisfactory arrangements have been made with respect to client files;
(iii) In circumstances where CPA Nova Scotia required the applicant to carry insurance coverage that such insurance coverage remains in place or will respond to claims made against the applicant for at least six (6) year following the date on which the applicant ceased to carry on the practice of public accounting or a regulated service; and
(iv) The applicant does not hold money or other property in trust for any client.

I Acknowledge that, pursuant to By-law 223, a CPA Nova Scotia membership certificate is the property of CPA Nova Scotia. Furthermore, I Declare that if a membership certificate was issued to me, it has been destroyed, returned to CPA Nova Scotia or that its location is unknown to me.

I Undertake in a circumstance where a lost certificate is recovered, I will forward it forthwith to the Chartered Professional Accountants of Nova Scotia.
